countries embodying three distinct stratification systems, make sense of this change.

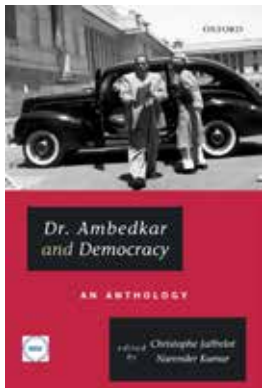

Dr B.R. At the core of the debate are serious issues of justice and history intertwined with politics and economics. These debates over land are already prominent in contemporary India and are expected to become even more so in the coming decade, given the anxieties over rural distress and the problem of livelihoods and popular politics, and public policies, in India will have to stay engaged with the debate on land at their core.
